4. FIRST AID MEASURES

First aid measures

General Advice

Immediate medical attention is required. Show this safety data sheet to the doctor in attendance.

Eye contact

Skin contact

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Seek immediate medical attention/advice.

Inhalation

Remove to fresh air. If breathing has stopped, give artificial respiration. Get medical attention immediately. Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.
